All structures erected on the Lots in the Property in accordance with this Declaration shall have their front doors facing the street and shall meet the minimum requirements, specifications and standards of the Uniform Building Code or the HUD Code, or Uniform Building Code or HUD Code equivalents, as the same may be amended from time to time, and as the same may be interpreted and enforced at the applicable time by the City of Rock Springs. The structures erected on the Lots in the Property in accordance with this Declaration which are intended for residential purposes shall be models which are no more than Ten (10) years old calculated from the date of installation on the Lot. structures erected on the Lots in the Property in this Declaration intended accordance with accessory or other purposes, shall be new, first-time use structures. All of the structures erected on the Lots in the Property in accordance with residential, Declaration, whether intended for accessory or other purposes, shall be permanent and affixed, and shall be of a quality consistent with the other structures located on the Lots in the Property and located on the Lots in the Skyview Estates First,
